



VILLAGE OF SILTON

BYLAW 01-2024

A BYLAW to establish rates for a Minimum Municipal Tax.

The Council of the Village of Silton enacts as follows:

That the following amounts be levied as the Minimum Municipal Tax payable for the 2023 taxation year and all subsequent years, unless otherwise repealed:

1. Agricultural - Land with or without improvements - \$750.00
2. Residential - Land with no improvements - \$600.00
Land with improvements - \$750.00
3. Commercial - Land with no improvements - \$600.00
- Land with improvements - \$750.00

Bylaw 02-2023 is hereby repealed.

This Bylaw shall come into force and take effect on the 16th of April, 2024.
